Question 1 - Comment puis-je résumer les étapes de la méthode Sexto?

To summarize the steps: First discuss the person who brings the incident to your attention. Apply the Sexto intervention kit to the person. Based on what is discovered, additional meetings may be required if there were other witnesses. Once all the information is gathered, from the answers you will need to verify if it was a malicious act or an impulsive one. The police will need to be contacted from this point and continue with their investigation if a malicious act or give an information session if an impulsive one. The pictures are never to be reviewed by school personnel and it is recommended that the police be involved (even in cases of an impulsive act. They will review the Sexto information with the students involved).

Question 2 - Qu'est-ce que je retiens des 3 mises en situation présentées?

The police must be involved in all cases - whether malicious or impulsive.

No school staff are to look through the phone for the images.

Gather all information from the person bringing you the situation and all witnesses to it. Confiscate the cell phone of any student with malicious intent. Do not meet with the student with malicious intent and get the police involved right away. For impulsive acts, meet with both parties and complete the Sexto information gathering. Advise of the importance of privacy and policies of the establishment.

Do not talk to the media. Advise that someone from the establishment will contact them.

Question 3 - Quelle étape me semble la plus délicate lors de l'application de la méthode Sexto?

The most delicate step in applying the Sexto step to me is involving the police. Especially for incidents where the student does not wish us to. She may be a victim or afraid of her parents finding out. We must reassure her that the police involvement is for her own safety in that the images will be deleted. The police are a safety measure to assure the party who received the photos does in fact delete them and is aware of the consequences if they do not.

It would be in the explanation of this point to the person coming to see me that would be challenging as they see me as a person of confidence and may feel that being broken by me telling the police about what occurred. I do see it as a necessity and the police must be made aware as soon as possible. The student will understand that it is not a breach of confidence, but a next step in assuring their safety.
