Sexto response kit 1 - Explorateur



Description:

For legal reasons, the use of the SEXTO kit is reserved exclusively for Quebec's education sector personnel. In addition, its use must be the subject of a prior agreement between the police force that serves the territory where the school is located and the Director of Criminal and Penal Prosecutions (DCPP). Please note that an attestation badge will only be attributed to personnel at education institutions in a territory where such an agreement has been concluded. Before completing the training program, it is therefore recommended that you validate this information with your superiors or your police force. This training program is designed to equip education sector personnel to act quickly and efficiently with the students in their institution who are involved in a sexting situation. Sexting among teenagers can be defined as the shared production, distribution, and redistribution of sexual content (photos, videos, etc.) via information and communication technologies. At the end of the Explorer level of this training program, you will be able to understand the phenomenon and guide those involved in the management of cases that could be brought to their attention through an intervention tool, namely the Sexto kit. At the Architect level, through interactive organized activities, you will be presented with three fictional cases of sexting in order to consolidate new learning and validate your interventions. The creation of the Sexto kit was made possible thanks to the collaboration of the City of Saint-Jérôme (Quebec), the Director of Criminal and Penal Prosecutions (DCPP), the Canadian Centre for Child Protection, the Crime Victims Assistance Centre (CAVAC), Commission scolaire de la Rivière-du-Nord, and Académie Lafontaine. Question 1 - What have I learned from the Sexto intervention method?

When a parent reports a sexting incident we must refer the parent to the police. The sexto intervention method is used when students report incidents to us. We are not representatives of the police and should not complete the sexto method for them. When a malicious act occurs, we should not question the student involved and has inappropriate photos or videos on their phone. We should confiscate their phone and immediately contact the police who will legally confiscate the phone and question the student or students involved. We must never view photos involved in sexting incidents.

Question 2 - What will this training change in my future interventions?

The training and the sexto intervention method will help me support students that are victims in sexting incidents. We now have a guide that we can follow in such cases.

Question 3 - What will be my focus with the students when I have to intervene?

My focus will be to determine if the act was impulsive or malicious and to support the victim of a sexting incident. I will also do what I can to stop the dissemination of inappropriate photos or videos by confiscating the phone during a malicious act and contacting the police.
