### Sexto response kit 2 – Architecte



#### Description:

For legal reasons, the use of the SEXTO kit is reserved exclusively for Quebec's education sector personnel. In addition, its use must be the subject of a prior agreement between the police force that serves the territory where the school is located and the Director of Criminal and Penal Prosecutions (DCPP). Please note that an attestation badge will only be attributed to personnel at education institutions in a territory where such an agreement has been concluded. Before completing the training program, it is therefore recommended that you validate this information with your superiors or your police force. This training program is designed to equip education sector personnel to act quickly and efficiently with the students in their institution who are involved in a sexting situation. Sexting among teenagers can be defined as the shared production, distribution, and redistribution of sexual content (photos, videos, etc.) via information and communication technologies. At the end of the Explorer level of this training program, you will be able to understand the phenomenon and guide those involved in the management of cases that could be brought to their attention through an intervention tool, namely the Sexto kit. At the Architect level, through interactive organized activities, you will be presented with three fictional cases of sexting in order to consolidate new learning and validate your interventions. The creation of the Sexto kit was made possible thanks to the collaboration of the City of Saint-Jérôme (Quebec), the Director of Criminal and Penal Prosecutions (DCPP), the Canadian Centre for Child Protection, the Crime Victims Assistance Centre (CAVAC), Commission scolaire de la Rivière-du-Nord, and Académie Lafontaine. The Sexto Kit training program was developed by CADRE21 and carried out thanks to the participation of Fédération des établissements d'enseignements privés (FEEP) and funding from the ministère de l'Éducation et de l'enseignement supérieur (Quebec ministry of education and higher education, or MÉES).

# Sexto response kit 2 – Architecte

Question 1 - How can I summarize the steps of the Sexto method?

First you should review the preliminary steps (talk to the person who reported the incident, as well as the victim, and others), evaluate the incident to determine trigger, nature, intentions, and extent then verify the information by completing the incident evaluation grid separately with each person involved. At this point if you think this is a malicious act we would contact the police for them to take charge and not complete an incident evaluation grid with the instigator however we would meet with him to confiscate his cell or electronic device. Parents will need to be informed and the situation should be brought to the attention of DYP.

If we decide not this may not be a malicious act we would continue the process by talking with the instigator to gather information in order to be better equipped to determine if the act was impulsive or malicious. In the case of an impulsive act we would complete the incident evaluation grid and consult the school boards policies. If it seems that there could be possession or dissemination of child pornography you should temporarily confiscate the instigators cell (ask them to turn it off and place it in a sealed bag). After this you contact the police, inform the parents as soon as possible of all parties involved, and contact DYP.

Question 2 - What have I learned from the three situations presented?

I learnt that it is important to fully understand the sexto method, when, and how to apply the procedures. I understand that we do not represent the police or any type of police intervention and that we can not be asked to act on behalf of them (even when it is an officer that asks us). I understand that the sexto method applies does not apply to certain situations and that it is important to be aware and have a clear understanding of each situation that is presented to us. I realize that sometimes the situation can change and information can arise after some time has passed because the individuals may be scared to share what happened. I also learnt that action must be taken even when the situation is reported by a concerned friend and the person involved does not want to give consent to talk about it.

Question 3 - Which step do I find the most delicate when applying the Sexto method?

For me the most delicate step would be getting the details of the incident and recording the sensitive information on the incident evaluation grid.
