Sexto response kit 2 – Architecte



Description:

For legal reasons, the use of the SEXTO kit is reserved exclusively for Quebec's education sector personnel. In addition, its use must be the subject of a prior agreement between the police force that serves the territory where the school is located and the Director of Criminal and Penal Prosecutions (DCPP). Please note that an attestation badge will only be attributed to personnel at education institutions in a territory where such an agreement has been concluded. Before completing the training program, it is therefore recommended that you validate this information with your superiors or your police force. This training program is designed to equip education sector personnel to act quickly and efficiently with the students in their institution who are involved in a sexting situation. Sexting among teenagers can be defined as the shared production, distribution, and redistribution of sexual content (photos, videos, etc.) via information and communication technologies. At the end of the Explorer level of this training program, you will be able to understand the phenomenon and guide those involved in the management of cases that could be brought to their attention through an intervention tool, namely the Sexto kit. At the Architect level, through interactive organized activities, you will be presented with three fictional cases of sexting in order to consolidate new learning and validate your interventions. The creation of the Sexto kit was made possible thanks to the collaboration of the City of Saint-Jérôme (Quebec), the Director of Criminal and Penal Prosecutions (DCPP), the Canadian Centre for Child Protection, the Crime Victims Assistance Centre (CAVAC), Commission scolaire de la Rivière-du-Nord, and Académie Lafontaine. The Sexto Kit training program was developed by CADRE21 and carried out thanks to the participation of Fédération des établissements d'enseignements privés (FEEP) and funding from the ministère de l'Éducation et de l'enseignement supérieur (Quebec ministry of education and higher education, or MÉES).

Sexto response kit 2 – Architecte

Question 1 - How can I summarize the steps of the Sexto method?

- 1) Prepare the Sexto Kit: Gather all required materials and resources for the protocol, ensuring everything is organized and nothing is missed.
- 2) Use the Checklist: Follow the checklist to make sure each step is completed, keeping everything structured and consistent.
- 3) Do Not Consult the Images: Focus solely on the steps and the facts to ensure the situation is handled correctly.
- 4) Complete the Evaluation Grid: The intervener should fill out the evaluation grid, working with each party involved to collect all necessary information.
- 5) Coordinate with the Police: The intervener must communicate with the police to explain the situation so they can investigate further and find an appropriate solution.
- 6) Sexto Education: At the conclusion, the police must apply Sexto Education with all parties involved to address the situation and ensure everyone is properly informed.

Question 2 - What have I learned from the three situations presented?

I have learned that it's essential to thoroughly evaluate the situation before taking any action. For example, when a student reports something to an intervener, they must follow the correct procedures, such as completing the Sexto Protocol. This involves working with the student to fill out the evaluation grid, while also considering input from other relevant parties. This collaborative process helps create a comprehensive understanding of the situation, which is crucial when contacting law enforcement. The police will then investigate the matter, and it's important to ensure that a Sexto Education meeting is scheduled with all involved parties to address the issue properly and ensure everyone is informed and supported. There is also a necessary collaboration between the school intervener, the police, and the students involved to ensure all perspectives are considered and appropriate actions are taken.

Question 3 - Which step do I find the most delicate when applying the Sexto method?

When directing parents to the police, it's important to assess the situation and choose the best approach. You might want to offer support, especially if it's a sensitive or urgent issue. However, it's also important to follow the protocols in place, making sure everything is handled correctly and all the right people are involved as sometimes the sexto protocol cannot be applied depending on the case. While it can be tough to step back, trusting these processes helps keep the investigation on track and ensures everyone's safety. You can still be there to guide and support the parents through the process, so they don't feel alone during a stressful time. To summarize when the sexto protocol cannot be applied you must refer the individual to the police force.
